

FEE-FIXING RESOLUTIONS FOR THE YEAR 2021
LOCAL GOVERNANCE ACT, 2016 (ACT 936) SECTIONS 124-152

In accordance with Section 144 & 145 of the local Governance Act, 2016, (Act 936), the following rates, fees, licenses, rents, fines and other charges have been imposed by a resolution of the Adansi South District Assembly for the financial year 1st January to 31st December, 2021 at its sitting at the District Conference Hall, New Edubiase on 29th September, 2020.

(A) RATES

(1) Basic Rates

Under Sections 144 (4) & (5), a Basic Rate of GH¢ 1.00 Per year is payable by all Persons of or above the age of 18 years who reside within the area of authority of the Adansi South District shall be paid to the Adansi South District Assembly.

2) Property Rate (Section 144 (6-11))

In addition to the basic rate, the following rates are being imposed on all immovable properties situated within the administrative area of the Adansi South District Assembly except for rating under the provisions of section of 144 (12) of the Act, the amount which shall be seen out in the schedule below

Under Section 148 of the Local Governance Act , 2016, Act 936

This notice constitutes the effective making and levying of such Rate/Fees Licenses as from 1st January 2021 to 31st December 2021. It shall be the duty of every Person liable to pay these Rates/Fees/Licenses to pay the amount thereof at the offices of the Adansi South District Assembly unless such Person has paid the said Rate/Fee/License to a collector or any authorized Person at any place.

PENALTIES (LOCAL GOVERNANCE ACT, 2016, (ACT 936), SECTIONS 156, 159, 160, 162 & 168)

1. Any Person, who without any lawful justification or excuse, the proof of which lies on Him/Her, refuses or willfully neglects to pay any fees, licenses, charges payable by him/her on or before the stipulated date shall pay a penalty of GH¢25.00 for Basic rate and 3 times the amount owed for other Rates, Fees and Licenses. This is without prejudice of any action the court might impose rate together with the amount defaulted.

2. The Assembly shall constitute a Task Force at any time to embark on Revenue Mobilisation Campaign. The Task Force has

power to lock up stores and premises of recalcitrant Ratepayers and put them before court.

3. Any Person who willfully obstruct a Revenue collector, Task Force member or accredited agent of the Assembly to perform his legitimate duty shall pay a penalty of 3 times the amount owed and a refund of medical bills and the cost of material(s) destroyed is without prejudice of any action that might be imposed on him/her by the court.
